

REGULATIONS

on membership dues for the members of Public Association "Jewish Community of Republic of Moldova"

I. General provisions

- 1.1. Said regulations on membership dues for the members of Public Association "Jewish Community of Republic of Moldova" (hereafter referred to as "Community" or "JCRM" in this document) are created according to:
 - a. Civil Code of Republic of Moldova
 - b. The Law number 837-XIII dated May 17, 1996 "On Public Associations"
 - c. The Charter of Public Association "Jewish Community of Republic of Moldova".
- 1.2. Said Regulations on membership dues of the members of the Community are approved, changed, amended, and abolished by the decision of simple majority of members in the Presidium of the Community.
- 1.3. Membership dues are funds which are considered one of the sources which form ownership of the Community, and these funds are submitted by members of the Community on voluntary basis to finance goals and tasks specified in the Charter.
- 1.4. Presidium of the Community determines amount and payment procedures for membership dues.
- 1.5. Compliance to said Regulations is ensured by the Director of the Community.

II. Membership dues

- 2.1. Membership dues are paid annually, starting with January first and ending with December 31st of each calendar year.
- 2.2. First annual membership due amount is paid starting with the year in which the said Regulations were approved.
- 2.3. Minimal amount of annual membership dues constitutes 250 (two hundred and fifty) MDL. Targeted annual membership dues constitute 2000 (two thousand) MDL. Social Card is issued for free, according to the list, maintained by Social services.
- 2.4. All details on membership dues can be found in Addendums 1.1, 1.2, and 1.3 of the said document.
- 2.5. Membership dues can be paid by a transfer to the bank account of the Community, given the following requisites:

*it can also be done by paying cash directly to the Community cashier.

- 2.6. Annual membership dues can also be paid according to payment schedule. See all schedule details in Addendum 2.1
- 2.6. By paying annual membership dues the person making the payment validates his or her membership in the Community.
- 2.7. A failure to pay annual membership dues can be considered grounds for cancellation of membership status and rights, as stipulated in paragraphs 3.3 and 3.4 of the said Regulations.

III. Membership

- 3.1. Any individual of Jewish ethnicity older than 18 years of age, residing in Republic of Moldova, can be considered a Member of the Community.
- 3.2. An individual younger than 18 years of age becomes a member of the Community in case one of his parents paid his or her membership dues.
- 3.3. An individual meeting the requirements specified in the paragraphs 3.1 and 3.2 of the said Regulation is considered a Member of the Community as soon as his or her annual membership dues are paid.
- 3.4. A member of the Community has the following rights:
 - a. A right to participate in the activities of the Jewish Community of Republic of Moldova
 - b. A right to participate and to vote in the Reporting and Elections Conference of the Community (individuals older than 18 years of age);
 - c. A right to choose an amount of the annual membership dues.
- 3.5. A member of the Community has the following duties:
 - a. A duty to observe the said Regulations;
 - b. A duty not to inflict any moral or material harm to the Community in any way;
 - c. A duty to submit his or her data and a consent to use this data for JCRM database.

Regulation on membership dues for the members of Public Association "Jewish Community of Republic of Moldova" – Addendum Number 1

Addendum 1.1 "Standard"

Minimal amount of annual membership dues constitutes 250 (two hundred and fifty) lei.

Membership benefits:

- ✓ 15% discount on «JFuture» Sunday School participation;
- ✓ 5% discount on «Librarius» stores;
- ✓ 20% discount to participate in «Limmud» conference in Moldova;
- ✓ No fees on participating in seminars, conferences and other JCRM activities;
- ✓ 20% discount on tickets to Annual Community Pesach celebration;
- ✓ A reference letter for those wishing to enroll in Jewish educational institutions in Chişinău.

Addendum 1.2 "Social"

Jews falling into category "Socially vulnerable" may receive social cards. Each person's case will be agreed upon by social services of Jewish organizations. The card includes all benefits listed in the Addendum 1.2 "Standard".

*Note

Receiving the social card is free, but every JCRM member has a right to make an affordable contribution for the development of the Community.

Addendum 1.3 "Premium"

The amount of annual targeted membership dues starts at 2000 (two thousand) lei and is unlimited.

Additional benefits included in Premium membership, in addition to "Standard":

- ✓ 20% discount on the cost "Nesharim" camp session;
- ✓ Free participation of the card owner in Annual Community Pesach celebration;
- ✓ One kg of matza free of cost;
- ✓ A gift from JCRM A calendar for the next Jewish year;
- ✓ Special conditions on children's programs for presentations, program management, Microsoft Excel, and public speech from SRC business school;
- ✓ Free subscription for "Our Voice" newspaper;
- ✓ Free Romanian language tutorial (72 hours) from International Center for Professional Development (hereafter referred to as "ICTPD");
- ✓ Free English language tutorial (72 hours) from ICTPD;
- ✓ Free tuition for programs for the unemployed, when one is recommended for job search and job placement.
- ✓ Free attendance of Sunday classes for Torah study from ICPD.

*Note:

Addendum 2.1

A member of Jewish Community has a right to choose membership dues' payment option which is most convenient for him or her.

The payment can be made in one of the following ways:

- \circ A single payment 100% of the amount paid once a year;
- \circ Once every six months 50% of the membership dues amount chosen paid each time;
- Quarterly 25% of the membership dues amount chosen paid each time.
